#### **Event Celebration**

#### **GLOBAL HAND WASH DAY**

#### Date: 15.10.2020

#### **Activities Undertaken:**

The MHV staffs went to the village. They organized awareness program on Hand washing at our routine village. They did the program after doing OPD. After checked medical officer then we had arranged for how to cleaning for hand and methods to be explained to village people.

#### Summary of the Program:

The MHV staffs went to the village. They met and interacted with the village people. They organized program on Global Hand washing in village. Around more than 80 people and students were total participated in the program. The doctor of MHV talked about hand washing. They said what to do to keep the body healthy. They said they could have a much bigger disease if they were not clean. They said when to wash their hands. They showed the poster and also told positive and negative side of hand washing. They said about 7th steps of Hand Washing and practical showed with thestudents. They said to village people and students how to do seven steps of hand washing in front of everyone. Then a student showed seven steps of hand washing to everyone. They explained that to keep the body healthy, we have to keep ourselves clean. Then the hand washing poster was put on the MHV vehicle. It was hung on the Van because it was in front of their eyes. So that they don't forget to stay clean.





#### **International Women's Day Celebration**

Date: 8<sup>th</sup> March 2021

Place: Khejariyali

We usually talk about the empowerment of women and to embrace them but one thing what we have found is we tend not to celebrate them as they are and find ways not to showcase their aptness, which results in not liberalizing their choices and keeping underprivileged without letting them realize the surreal type of celebration.

Hence, Dhara Sansthan under MHV program could get an opportunity to celebrate them on international women's day on 8<sup>th</sup> March, 2021 at a village called Khejariyali and the MHV team could make them aware about the importance for being a woman, to celebrate themselves by taking their care and so on. Along with the session through MHV could also distribute sanitary napkins to make them aware their menstrual health and hygiene and shared the tips about staying focused and achieving one's dream as well.



#### City Awareness-

Due to rise in COVID cases, an awareness drive was been ran from 21<sup>st</sup> March to 31<sup>st</sup> March 2020 and covered 367 awareness drives (Barmer City), wherein some locations were on repeat mode.

After that on 15<sup>th</sup> May, the awareness drive was again begun in the Barmer city, due to much rise in the number of corona case in the city and MHV decided to begin the awareness drive back. As a result, could cover all 55 wards with 2800 visits in the city through an auto.



And on 3<sup>rd</sup> October 2023, the corona awareness vehicle rally was been inaugurated by the environment minister Mr. Sukhram Vishnoi hence, DHARA Sansthan decided to start the awareness drive in the Barmer city,due to increasing number of corona cases in the city.

These locations are majorly in and around the entire city. Wegave a special focus to the areas where there was a possibility a crowd at a place and also gave special attention to District hospital and Market areas.

#### Village Awareness-

The city awareness drive that was begun since 21<sup>st</sup> of March at various villages of Barmer villages until 15<sup>th</sup> of May,2023. And as a result, could run the drive to a **total of 979 villages** of the district through Tavera (four-wheeler).

Dhara team has been spreading awareness to respond COVID- 19 disaster through MIC, pamphlets, and hand wash sessions. The team has been following all the guidelines of the government and practicing the norms of physical distancing and using the masks while in the field. This initiative is essential for the rural part of the district in the time of such pandemic and spreading preventive measures to respond Covid-19 through which could reach 18 blocks in Barmer and 2 blocks at Jalore District.

#### **Provided sanitary pads**

Covid-19 Lockdown affects the availability of sanitary pads inrural area and this impacted on the health condition of women in rural area. Dhara Sansthan and Vedanta Cairn Oil & Gas continuously working in the rural area of Barmer through Mobile health Van, so in the lockdown the work was still on the wheels. After recognizing the needs, Dhara Sansthan could successfully distribute 2158 sanitary pads to the rural women of Barmer district.











#### <u>Handwash Sessions –</u>

**Objectives** – The objective of this campaign is to raise awareness about the hand washing with soap to prevent from diseases. Hand washing is considered obligatory before taking meal and after using toilet.





**Activities** - During the COVID-19 pandemic, we did handwash practices with peoples during awareness drive, we taught peoples about correct way to hand wash and when hand should be washed with soap. Also, we distributed masks to them.



#### Physical (Social) distancing Marking -

Physical distancing marking in the public places is the good initiative to stop the spread of Covid-19. Social distancing, also called "physical distancing," means keeping space between yourself and other people outside of your home.

To practice social or physical distancing Dhara Sansthan team has marks the sign of physical distancing in the public places and introduces the importance of practicing it. The team introduce following things to the people and shop keepers and importance of practicing it.

- 1 Stay at least 6 feet (about 2 arms' length) from other people
- 2 Do not gather in groups



3 Stay out of crowded places and avoid mass gatherings.



#### Distribution of Mask, Sanitizer, V-44 masks, and Hand gloves -

The second most important task accomplished by us was distribution of masks and sanitizers. We all knew corona is a disease which can only be prevented if proper precautions and hygiene practices are adopted.

The rural and urban population of Barmer had to be well equipped with them and an early approach to this was generated.

We started this from 23rd March 2020. A vast area both in the urban as well as rural population was covered.

Details of Mask, Sanitizer, V-44 mask and Hand Gloves mention in below table -






The sanitizer bottles were filled and labeled into smaller 100 ml, 250ml, 180ml, and 1litre bottles by the staff of Dhara. And we made people get handmade masks in order to make itreusable by the communities.

During this pandemic situation MHV covering Barmer city in the month of May to August2020 and provide health care supports to Corona patients, we provide regular heath checkups and medicines to home quarantine patients.


#### <u>Total OPD in Barmer city (May to August 2020) -</u>



# Childline:

# Supported by Childline foundation India.

Supported by: Ministry of Women and Child Development, Government of India CHILDLINE started in 1996, India's first 24-hour helpline service supported by the Ministry of Women & Child Development. The service is for children in need of aid and assistance and is provided through a toll-free 24- hour emergency phone service (1098). Apart from responding to emergency needs, it also helps in linking children in difficult circumstances with various services meant for their long-term care and rehabilitation. Thisone-point contact is meant to facilitate instant access to support, guidance, and active intervention.





#### **Awareness Camps**

Various awareness camps were conducted at various places in Barmer. The purpose of organizing camp has been to aware people at mass level regarding the social and traditional evil practices which are killing the rights of children. It is important to address these issues and provide the sound and child friendly environments for their appropriate developments.



The second purpose of organizing the camp was to aware the people about the lawsand rights given to the children in the constitution of India. Even the government had made a separate law to protect the children from violation.

Various awareness camps were organized at different village in Barmer in which we distributed educational kits to the children as per their necessity.

□ In the state Milaap-1 Abhiyaan started from February 01, 2021 to February 28 2021 in which Rajasthan State Govt. Police department giving attention on pending cases of missing children and rescue of child labors and baggers. The aim of this Abhiyaan is to search minor/juvenile children and rehabilitate them. Childline Barmer team attended the meeting at SP Office Barmer which leaded by SP Barmer. We assure police department that ChildLine Barmer team will give support to them and work on this Abhiyaan.



- Team member talked to lady and found his oneson is mentally retarred. Team requested lady to give child to CWC (Child Welfare Committee). She denied. Team started helping her. Her



Youngest kid is 1.5year old. Team firstly asked about her documents. She said all werestolen by somebody she was having only "Janadhaar Card". On the basis of Janadhaarteam found his adhaar card. Team collect his husband's death certificate from Municipality. Then Team helped her in starting "Widow Pension Scheme". Team prepared all the documents.

Team tried to collect some amount so that she canlive a dignified life. Childline team working for this lady only for betterment of children future.

Team requested Municipality Chairman Shri Dilip Maali ji for help. He personally gave commitment to feed that lady's complete family in "Indira Rasoi". Ultimately lady's food becomeFree for atleast one year.

# **Small Holder Farming:**

The ongoing health crisis around Covid-19 has affected all walks of life. During these challenging times, the agriculture system has been disrupted impacting farmers livelihood. With Kharif sowinground the corner we are striving to support small holder farmers with input requirements for a productive season.

Through this program, Bayer Prayas provided free of cost Agricultural Input Kits as well as trained the small holder farmers by promoting adoption of the best practices in crop production and protection to improve their earnings substantially. This was an opportunity for helping the farmers secure their livelihoods. Bayer Prayas Association with implementing agency DHARA Sansthan had been engaged in reaching out to farmers and carried out the following activities:

- Distribution of input packages to the farmers in the designated geographies within a specific timeframe
- Conducted training sessions for farmers on best practices in crop production and protection
- Hand holding farmers through the crop cycle
- Conducted post- harvest meetings
- Supported allied activities like base line survey/ impact survey
- Data generation and assimilation.

Dhara Sansthan was responsible for driving the trainings, identifying and working

on the selected demo plots. The Training of the farmers, Managing the small holder project and ensuring the demo plots to perform as per the requirement.





## Covid-19 Disaster Preparedness And Relief Project - Supported By Wind World Goal:

Overall goal of the project is to prevent, protect, control COVID 19 and offer essential lifesaving relief materials (mainly the essential food products as dry ration) to the ones who are in immediate need of it or highly impacted by their livelihood during this pandemic. Here we term the essential supply to food products to one family as "Relief Kit".

#### **Objectives:**

To distribute "Relief Kits" with dry ration package to 300 households/families for the prevention of hunger / starvation deaths due to COVID 19 disaster. This total coverage of 300 families will be targeted over the period of 2 months in two phases.



#### **Project Period :**

In two phases: (i) Phase 1 = 1 month (ii) Phase 2 = 1 month

#### Project Area: Identified Villages in Jaisalmer district of Rajasthan.

As per a preliminary survey by Dhara Sansthan and based on our discussion with local site personal of Wind World Project Sites (Rep. of Vayu India, Vish Wind and other group companies of the organization), we intend to cover at least 4-5 villages in Jaisalmer districts such that a minimum of 300 families can be covered under this program over a period of 2 months.




#### **Project Deliverables:**

#### Strategies at the Level of the Identification of AME

Recognition by the community resource person/mentor of the entrepreneur bridging gaps in basic and initial need help that failed his/her enterprise due to COVID-19 epidemic. A group deep brainstorming conversation has been taken place over the time to understand his/her basic mindset/motivation towards startup idea.

#### Criteria to select the appropriate AME

A small number of entrepreneurs 25, but highly desperate and motivated have been selected out of 100 entrepreneurs. That has come out, after having a many of conversations with the entrepreneurs to identify the right beneficiary for the project. That was the most important




part of the project, to make the project successful. All the enterprises were already decided about their activities based on the available resources and scope of the startup. There were 4 major criteria have been decided those are following-

- One should have decided the activity
- One should have enough place to start the activity
- One should have arranged enough financial support start the activity
- One should have prior experience /training/knowledge about the activity decided by him/her

The entrepreneur having all above following eligibility criteria with full motivation and ownership sense to the activity was only criteria, to get selected.

#### Tools to monitor the livelihood /Startup

Apart from the facilitation and mentorship, livelihood counseling sessions have been conducted to keep motivated all of them. Inputs from the mentor to start the enterprise, ongoing issues, challenges faced by the entrepreneur and regular monitoring through home visits






#### Criteria for a successful AME

So the basic criteria to identify a successful AME was, if he/she is able to continue with thesame activity and able to manage all finances at least for 6 months. It means the AME haslearnt how to run the startup independently, at this point of time Dhara Sansthan tries to get in touch with him/her regularly and provides a handholding support to keep motivated and prosperous.
